8. Incomplete / ineligible applications will be deemed invalid and rejected without intimation to the candidate. Only the eligible candidates will be called for the written examination.

(c) Application form incompletely filled including photograph, attested docus etc.

(d) Two or more application filled for the same post by applicant.

(e) Any other influence from outside or use of wrong procedure for acceptance of the application.
